Entry Requirements

1. Entry form must be postmarked by the entry date on the individual competition or contest.
2. Entry forms must be legible and complete with fees, in order to be accepted.
3. ENTRY FEE: NO refunds. See competition or contest for entry fee.
4. Receipt of entry form will not be acknowledged, except for contests. Please include entry fee with entry form. Entry form received without required entry fee will be returned to you for fee.

5. You must be 17 years of age or older, unless otherwise stated.
6. Entries accepted from INDIVIDUALS ONLY, unless otherwise stated.
7. All articles entered must be the handiwork of the exhibitor. If, in the opinion of management, an article has previously been entered, the Fair reserves the right to withhold the item from judging and display. Items can only be entered in the L.A. County Fair once.
8. Only items listed and described on the entry form will be accepted for judging.
9. Articles that are stained or soiled or articles showing obvious signs of wear or use will be disqualified. Fair reserves the right to reject any exhibit or entry, if there is anything objectionable, unsuitable, or requires more space than can be given, or is in conflict with exhibit requirements. See Division for limitations on weight and size.
10. All articles must not exceed 25 pounds, have sturdy hardware, and be ready to hang. Articles designed for hanging that are not so-equipped will be displayed in a manner deemed appropriate by the Fair.
11. In classes calling for "any, specify" or "other than listed, specify" be sure to indicate on entry form the kind of item being entered.
12. To be eligible for a senior citizen award, exhibitor must be 65 years of age or older.

Delivery of Entries

13. Check the individual competition or contest for delivery dates and times.
14. IDENTIFICATION TAGS will be issued for all items entered and exhibitors will be given a claim check for each item.
15. DIRECTIONS: Take San Bernardino Freeway (10) to the city of Pomona. Exit on Fairplex Drive, go north to McKinley Avenue, turn right, continue on McKinley until you come to Gate 1, turn left, and get directions from security guard.
16. MAILED ENTRIES: Must be postmarked by July 9, 2009.
17. Shipped entries must include a photocopy of the original completed entry form,

**Original ENTRY FORM and FEE must be

18. **EXHIBITS RETURNED:**
Tuesday, October 6, 2009 from 7:00 a.m. to 8:00 p.m. unless otherwise stated.
19. Bring your claim check(s). If your claim check is lost, you must show I.D. before we will release the items. If you are unable to pick up your items, have friend bring your claim checks for you.
20. ENTRIES RETURNED BY UPS:
Exhibitors who send articles to the Fair and wish them returned by UPS must enclose with entry form, a check for \$20.00. Articles will be returned by October 31, 2009. BREAKABLE, FRAGILE, or extremely BULKY or HEAVY articles will NOT be returned by UPS; SUCH ITEMS MUST BE PICKED UP.
21. SIZE LIMITS: Size of item not to exceed 130 inches in length and girth combined.
22. Proper packaging materials MUST accompany all exhibits that are to be shipped back.
23. Entries must be picked up on Tuesday, October 6, 2009 by 8 p.m. Unclaimed articles will be donated to non-profit charities.
